
CONTRACT

THIS AGREEMENT, made this 28th day of April, 2020 between HON. GUILBERT P. BALLANGAN, of Tiempo, Tubo, Abra (hereinafter called the "ENTITY") and POWER V CALTEX SERVICE STATION, of Lipcan, Bangued, Abra (hereinafter called the "SUPPLIER").


Whereas, the entity is desirous that the contractor executes the Procurement of Diesel and Gasoline (Bayanihan Grant), hereinafter called the "WORK") and the Entity has accepted the Bid for **SEVEN HUNDRED NINETY NINE THOUSAND NINE HUNDRED EIGHTY NINE PESOS AND FORTY FOUR CENTAVOS** (php.799,989.44) by the supplier for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, words and expressions shall have the same meanings as are respectively assigned to them in the conditions of the Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this agreement, to wit:
 - (a) Omnibus Sworn Statement;
 - (b) BAC Resolution Recommending Approval by the HOPE
 - (c) Notice of Award
 - (d) Other contract documents that maybe required by existing laws and/or the entity.
3. In consideration of the payments to be made by the ENTITY to the SUPPLIER and hereinafter mentioned, the SUPPLIER hereby covenants with the ENTITY to execute and complete the GOODS and remedy any defects therein in conformity with the provisions of this contract in all respects.
4. The ENTITY hereby covenants to pay the SUPPLIER in consideration of the execution and completion of the GOODS and the remedying of defects wherein, the Contract Price or such other Sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this contract.
5. That the parties covenant to abide by the GENERAL CONDITIONS:
 - The work contemplated under this contract shall be construed in accordance with the instruction of the end user;
 - It should be understood that the quantities herein given are only approximate and the payment shall be based on the quantity of the GOODS actually delivered;
 - The SUPPLIER shall furnish all the needed GOODS for the


